About the Methodology Advisory Committee:

The 2nd SDE of Larissa and EEPEK were responsible for setting up the Methodology Committee. Its task is to finalize the contents of the methodology manual, which will continue to be reviewed and improved over the course of the project. The Methodology Committee sets out the terminology framework to guide interested users and stakeholders to better apply the results of STEPs.

The aim was to create a committee that consists of specialists who would be knowledgeable of all project plans and specifications in order to better understand and evaluate the evolution of the project at all stages.

FINAL CONFERENCE IN GREECE

An interesting two-day conference was co-organized on October 16 and 17 in "Gaiopolis" of the University of Thessaly by the Scientific Association for the Promotion of Educational Innovation (EEPEK) and the 2nd Second Chance School of Larissa (Prison) after the completion of all the Intellectual Outputs produced during the Erasmus+ program "STEPs".

During the conference, the participants were given the opportunity to enjoy a unique Virtual Reality (VR) experience. Through the stories of prisoners and released prisoners to experience their real struggles, while at the same time sharing the experiences of the representatives of the organizations participating in the program.

Members of the partner organizations presented the STEPs Guide for Implementation within the Detention Centers, which as an educational tool can support prisoners' reintegration.




FINAL CONFERENCE IN CYPRUS
